Instructions for Completing the Survey

- This form asks about your circumstances as of July 1.
If the head of household is absent or does not live in the household (generally for three months or longer), enter the name of the household representative in the "Head of household" field. The household representative should complete the survey as the head of household.
*A "household" is defined as a group of people who usually live together and share living expenses.
- Complete one survey for the household. In situations where two or more households live in the same home (for example, parents and adult children living together), they are treated as separate households if: (1) The residences are clearly separated, and/or (2) They do not share living expenses.
- Circle the numbers that apply to you, and fill in the appropriate numbers in the parentheses and squares.
- Refer to the "Instructions for Completion" if you are unsure how to complete the survey. If you have any questions, contact the call center listed in the "Request for Survey Cooperation" you received, or ask the enumerator when they come to collect the survey.
